## Preliminary Determination for an Air Quality Permit for

### Enterprise Field Services, LLC

Enterprise Field Services, LLC, PO Box 4324, Houston, TX has submitted an air quality permit application to the Air Quality Bureau (AQB), New Mexico Environment Department (NMED) for an air quality permit to modify the Potter Canyon Compressor Station. The application file has been assigned Permit No. 1984-M3 and TEMPO Agency Interest ID No. 1348. The exact location of the facility is at latitude 36 deg, 48 min, 12 sec and longitude -107 deg, 55 min, 16 sec. To aid in locating this facility, the approximate location is 4 miles Southeast of Aztec, NM (off NM Hwy 173) in San Juan County.

The proposed modification will consist of: 1) removing three 1,000 bbl oil condensate tanks; 2) adding one 500 bbl oil condensate tank; 3) adding emissions from malfunction events to the permit; &, 4) increasing emissions of Volatile Organic Compounds (VOC) from 93 tons per year (tpy) to 116 tpy.

Total air pollutant emissions to the atmosphere are estimated to be approximately 115.8 tpy of VOCs & 8.3 tpy of Hazardous Air Pollutants (HAPs). These emission estimates could change slightly during the course of the Department's review of the application.

The NMED has conducted a preliminary review of the information submitted with the permit application. Based on the applicant's analysis, a preliminary determination is that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 3, 72, 73, & 75; 40 CFR 50; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality permit on or before December 14, 2011. This source is a minor source according to 20.2.74 NMAC, PSD.

To ensure compliance with state and federal air regulations, the permit is expected to include conditions that limit the emissions and require record keeping and reporting to the Department.

The permit application is available for review in electronic or hard copy at the Air Quality Bureau Office, 1301 Siler Road, Building B, Santa Fe, New Mexico. The permit application is also available at the NMED Farmington Office, located at 3400 Messina Drive, Suite 5000, Farmington, NM 87402 for public review.

All interested persons have thirty (30) days from the date this notice is published, to notify the Department in writing of their interest in the permit application. The written comments should refer to the company name, site name and Permit No. (or send a copy of this notice along with your comments). The written comments shall state the nature of the issues raised and how it relates to the requirements of applicable state and federal air quality regulations and the Clean Air Act. The written comments should be mailed to Sandy Spon, New Mexico Environment Dept., Air Quality Bureau, Permit Section, 1301 Siler Road, Building B, Santa Fe, New Mexico 87507-3113.

The Department will notify all persons, who have provided written comments, as to when and where the Department's analysis may be reviewed. Although all written comments will be made part of the public record, any person who does not express interest in writing prior to the end of this first thirty (30) day period will not receive such notification.

If the Department receives written public comment prior to the end of the Department's thirty (30) day public notice, the Department's analysis will be made available for review for thirty (30) days at the NMED district or field office nearest to the source before the permit will be issued. Written comments on the analysis or permit application may be submitted to the Department during this second thirty (30) day period or at any time before the permit is issued or denied.
