

**LEGAL NOTICE**  
and  
**Preliminary Determination for an Air Quality Permit for**

**Williams Four Corners LLC – Aztec Compressor Station**

Williams Four Corners, LLC, 188 County Road 4900, Bloomfield, NM has submitted an air quality permit application to the Air Quality Bureau (AQB), New Mexico Environment Department (NMED) for an air quality permit to modify Aztec Central Delivery Point (CDP). The application file has been assigned Permit No. 1327M5 and TEMPO Agency Interest ID No. 1276. The exact location of the facility is at latitude 36 deg, 59 min, 35.3941 sec and longitude - 107 deg, 54 min, 45.2458 sec. To aid in locating this facility, the approximate location is 4 miles north-northwest of Cedar Hill, in San Juan County, New Mexico.

The proposed modification will consist of the addition of Malfunction emissions and the single annual emissions cap for SSM emissions.

Total air pollutant emissions to the atmosphere are estimated to be approximately: Nitrogen Oxides (NOx) at 115.0 tons per year (tpy); Carbon Monoxide (CO) at 202.7 tpy; Volatile Organic Compounds (VOC) at 171.3 tpy; Total Suspended Particulate Matter (TSP) at 2.8 tpy; Particulate Matter 10 microns or less (PM10) at 2.8 tpy; and Particulate Matter 2.5 microns or less (PM2.5) at 2.8 tpy; Formaldehyde at 12.6 tpy; and Total HAP at 13.3 tpy. These emission estimates could change slightly during the course of the Department's review of the application.

The NMED has conducted a preliminary review of the information submitted with the permit application. A full review will evaluate the estimated emission rates and applicable requirements to determine compliance.

Based on the applicant's analysis, a preliminary determination is that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 3, 7, 61, 70, 72, 73, 75 and 82; 40 CFR 50; 40 CFR 60 Subparts A & JJJJ; 40 CFR 63 Subparts A, HH, & ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality permit on or before October 30, 2011. This source is a minor source according to 20.2.74 NMAC, PSD.

To ensure compliance with state and federal air regulations, the permit is expected to include conditions that limit the emissions, and conditions that will require record keeping and reporting to the Department.

The permit application is available for review in electronic or hard copy at the Air Quality Bureau Office, 1301 Siler Road, Building B, Santa Fe, New Mexico. The permit application is also available at the NMED Farmington Office, located at 3400 Messina, Suite 5000, Farmington, NM 87402 for public review.

All interested persons have thirty (30) days from the date this notice is published, to notify the

Department in writing of their interest in the permit application. The written comments should refer to the company name, site name and Permit No. (or send a copy of this notice along with your comments). The written comments shall state the nature of the issues raised and how it relates to the requirements of applicable state and federal air quality regulations and the Clean Air Act. The written comments should be mailed to Melinda Owens, New Mexico Environment Dept., Air Quality Bureau, Permit Section, 1301 Siler Road, Building B, Santa Fe, New Mexico 87507-3113.

The Department will notify all persons, who have provided written comments, as to when and where the Department's analysis may be reviewed. Although all written comments will be made part of the public record, any person who does not express interest in writing prior to the end of this first thirty (30) day period will not receive such notification.

If the Department receives written public comment prior to the end of the Department's thirty (30) day public notice, the Department's analysis will be made available for review for thirty (30) days at the NMED district or field office nearest to the source before the permit will be issued. Written comments on the analysis or permit application may be submitted to the Department during this second thirty (30) day period or at any time before the permit is issued or denied.
